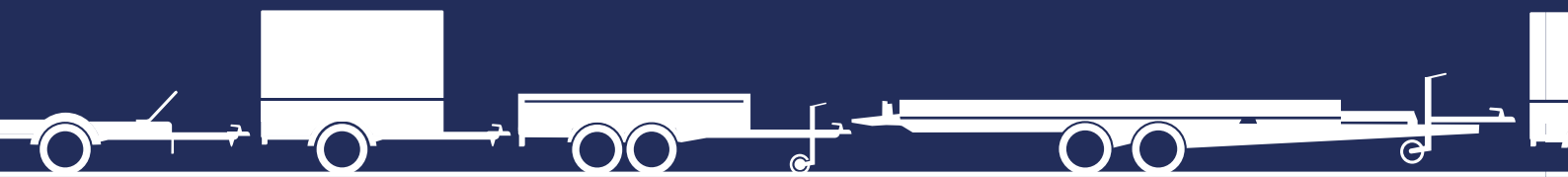


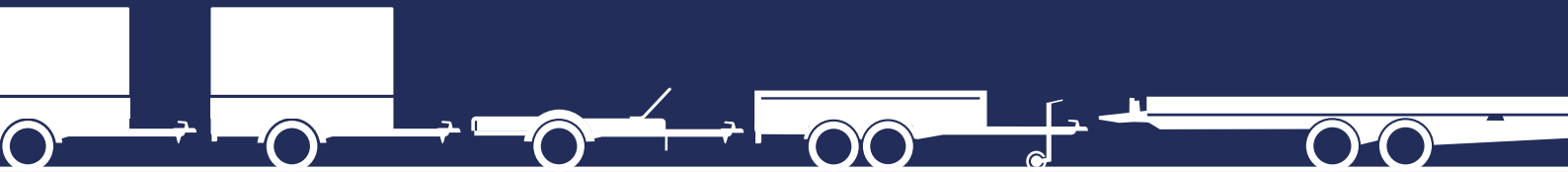

# PURPOSE OF ASSOCIATION

Trailer Industrie Verband e.V.



The purposes of the association include in particular:

- a) safeguarding the rights and interests of the trailer industry and public relations in the areas of industrial policy, of consumer protection, product liability and legal structuring,
- b) supporting and advising the legislative bodies and authorities at national, European and overarching international level in all matters affecting manufacturers and suppliers of trailers and trailer-related products,
- c) safeguarding the interests of the trailer manufacturing industry and suppliers vis-à-vis other national, European and other international industry associations,
- d) membership in national, European or other international professional associations as well as participation in companies of any type, insofar as membership or participation serve the purpose of the association or the members of the association,
- e) networking and know-how transfer between the members of the association through workgroups and the association's website.

### Future - Trailer

In times of rapidly changing mobility, tomorrow's question is about transport options in the future and the place of the trailer in this mobility concept.



### Autonomous driving

Autonomous driving is one of the most important future technologies in the automotive industry. What share will autonomous driving have in the future and what must a trailer look like in order to play an important role in this type of mobility?

### Electromobility

As TIV, we want to ensure that electric vehicles are also capable of towing loads and that transport ideas can be implemented. To this end, we will actively influence passenger car manufacturing with regard to the electrical interface and the trailer coupling.

Specifically, this means that we will work with car manufacturers to develop new standards for the electrical interface between electric vehicles and trailers.

### LCA of trailers

The topic of climate protection is also important in our association, which is why we are developing framework conditions for the ecological footprint of trailers in cooperation with a renowned institute.

### Driving licence reform

The aim is to accompany and critically question the driving licence-related EU regulations for driving licences. We work with authorities and legislators to promote the safety and user-friendliness of driving licence regulations.
